July 2023 Ordinance Adopting the August 1, 2022, Amendments to the West Virginia State Building Code

Whereas West Virginia Code §8-12-13(c) indicates that municipalities have the option to adopt the West Virginia State Building Code,

Whereas, on August 1, 2022, the State of West Virginia promulgated amendments to its State Building Code,

Whereas West Virginia Code §8-12-13(b) indicates that all existing building codes are null void one year after the State of West Virginia promulgates a State Building Code or amendments,

Whereas the City of Weston intends to continue its use of the West Virginia State Building Code,

Whereas, the City of Weston intends to adopt the most current version of the West Virginia State Building Code, in particular, its August 1, 2022, amendments,

Whereas the City of Weston intends to adopt and enact, by this ordinance, the West Virginia State Building Code and its amendments as promulgated on August 1, 2022,

Whereas the City of Weston's adoption of the August 1, 2022, West Virginia State Building Code and its amendments occurred within one year of promulgation of said amendments,

That the City of Weston now adopts, by this ordinance, the most current State Building Code as identified by:

Title 87 Legislative Rules State Fire Commission Series 4 State Building Code

The following amendments are made and incorporated into the codes adopted above:

The City of Weston will be free to fill in these sections once the information from Manual J becomes available to the City of Weston.

Concerning Table R301.2(1), if the relevant State Building Code charts, graphs, tables, or numbers contradict these numbers then the State Building Code chart, graphs, tables, or numbers shall be used.

Section P2603.5.1: This section shall read as follows:

"Building sewers that connect to private sewage disposal systems shall be installed not less than 36 inches (mm) (or current frost line depth if different) below finished grade at the point of septic tank connection. Building sewers shall be installed not less than 36 inches (mm) (or current frost line depth if different) below grade. - Building Permits \$25
- \$10 charge for every \$1000 of total cost of job/project

Example Chart

\$10 for first \$1,000

\$20 for \$1000.01 to \$2000

\$30 for \$2000.01 to \$3000

\$40 for \$3000.01 to \$4000

For job/project costing over \$4000, the fee schedule will proceed in a manner consistent with the above-cited Example Charter.

The City of Weston will utilize a "State Building Code" appeals board instead of a separate appeals board for each national code adopted in this ordinance. This Board may also be referred to as Code Appeals Board. Code Appeals Board shall mean the board which hears appeals stemming from the State Building Code.

If any portion of this ordinance shall be deemed unconstitutional or otherwise defective, the remaining portions shall remain in force.

The City of Weston may adopt one or more appendices of these national codes that are not included in the West Virginia State Building Code. The City of Weston will make that determination to adopt appendices at a later date.

This ordinance is adopted for the benefit, health, and welfare of the people of the City of Weston, West Virginia. This ordinance shall be effective on the day after this ordinance is passed.
